

Exubia Clerkenwell design week competition – terms and conditions

1. Promoter

This competition is organised by [Exubia Ltd](#) (“Exubia”, “we”, “our”, “us”).

2. Eligibility

- The competition is open to UK residents aged 18 or over.
- Employees of Exubia, their immediate families, associated agencies, or anyone professionally connected with the competition are not eligible to enter.
- Only one entry per person is permitted unless otherwise stated.

3. Competition period

- Entries must be submitted between 00:01 on 19 May 2026 and 23:59 on 21 May 2026.
- Entries received outside this period will not be counted.

4. How to enter

- To enter, participants must submit their details via the official competition entry form on the Exubia website.
- No purchase is necessary.
- Incomplete, illegible, or duplicate entries may be disqualified.

5. Prize

- One winner will receive a planted pot supplied by Exubia.
- The exact plant, planter style, and specification may vary and are subject to availability.
- The prize is non-transferable and no cash alternative will be offered.

6. Winner selection and notification

- The winner will be selected at random from all valid entries received during the competition period.
- The draw will take place within 14 days of the competition closing date.
- The winner will be contacted using the contact details provided on entry.
- If the winner does not respond within 14 days of notification, Exubia reserves the right to select an alternative winner.

7. Prize delivery or collection

- Exubia will arrange delivery of the prize to a mainland UK address provided by the winner.
- Alternatively, the winner may choose to collect the prize from Exubia's London showroom by prior arrangement.
- Delivery timings and arrangements are subject to availability and agreement with the winner.

8. Data protection and marketing

- Personal information supplied during the competition will only be used for the administration of the competition unless participants opt in to receive marketing communications.
- By entering, participants agree that Exubia may process their data in accordance with applicable UK data protection legislation.
